The 2015 AHA Online Instructor Update is Available

Below is the AHA announcement of the release of the 2015 AHA <u>Guidelines Online Instructor Update</u> Course. You should have already received the AHA email, but I've included it below. Please read it carefully and access the link to complete the update course by February 15, 2016 in order to continue teaching as an AHA Instructor. Once you click the link, you will be directed to login using your AHA Instructor Network username and password. Once your Instructor credentials are verified, you will be directed to the landing page for the course where you can choose the course you need based on your instructor discipline. You can also access the course through your Instructor Network Dashboard. The course will take approximately one hour to complete and includes bookmarking capability so it does not have to be completed in one session.

While it is recommended that BLS Instructors who also teach Heartsaver courses complete both update courses to gain a full understanding of the science changes that apply to each, it is not required. At a minimum, BLS Instructors who teach HS courses must access/download the Heartsaver Interim Training Materials from the AHA Instructor Network and use these materials until the new material becomes available.

When you have completed the online update course and evaluation, you will have the opportunity to print a completion certificate. You are required to provide this certificate to us, as your training center, in order to continue teaching as an active instructor. So please either email

it to office@lrncpr.com, fax it to 708.596.1818 or mail the completion certificate to us as soon as you have finished the course.

Once you have completed the instructor update you should begin using all the interim materials that were provided in a previous email. These materials are available by clicking the resources link within the online course as well.
